The disabled have a possibility to work out at the gym, however, there is no elevator there - the stairs are the only way to enter. It makes the gym not accessible for the disabled.






Virgen de las Nieves school

The situation from the gym repeated at the school. The area is quite large for the people in wheelchairs to move around, however, there is no other alternative for them than the stairs.



Negative aspects

We also encountered many difficulties while walking on the sidewalk and crossing the streets.



Positive aspects

Despite many difficulties the city also has many positive elements which facilitate the disabled. Special toilets or parking spots were wider and accessible in an easier way.



POSITIVE

- Lower floors and separate spaces for wheelchairs on public transport.
- Sound signalization at the traffic lights.
- Parking places for the disabled.
- Free health care and education.
- Socially active.
- Discounts at public facilities for the disabled.
- Various public fundraisers.
- Right to protest and express opinion publically.
- Separate toilets for the disabled.

- Illegal gay marriage, abortion, euthanasia.
- Not enough spots for the disabled eg. at the cinema or certain supermarkets
- Often there are no ramps or elevators at public places eg. banks, libraries.
- Parking spots for the disabled are often disrespected and occupied by people without disabilities.
- Many schools are not prepared for disabled students.

Positive

Lower floors and separate spaces for wheelchairs on public transport Parking places for the disabled Toilets for the disabled at schools and public places

Legal gay marriage in the church and legal abortion

Negative

No sound signalization at the traffic light Parking lots for the disabled are sometimes occupied and disrespected by others
